All appointments and re-appointments are subject to Board approval.

Independent Governors may currently be appointed for up to three terms of 4 years, although the Corporation is moving to a maximum of 2 terms of 4 years. All recommendations must go through the Search & Governance Committee. Previous time served as another category of membership is taken into account.

Parent Governors are nominated by parents at the College and their term lasts whilst their child or ward remains enrolled at the College.

Staff Governors are nominated by staff members at the College and their term lasts for a period of 4 years or less should they leave the employ of the College.

Student Governors are the elected Student Presidents of the College. Their term is for one year, whilst they remain students at the College.
